I understand the monthly storage rate is _____ a month. A month is considered from the day my vehicle is stored which becomes my anniversary date. From my anniversary to the day before my next anniversary is considered one (1) month. Daily storage is 10% of the monthly rate. Ten days of storage equals one month. I authorize the Auto Storage personnel to drive my car on, to and from storage areas utilized by it and store my vehicle at areas of their discretion.

STORAGE FEES ARE DUE EVERY MONTH, REGARDLESS OF REMOVAL DATE OR PAYMENT PLAN, OR LATE FEES APPLY.

I agree to notify All Services Auto Storage at least (7) days before I want my vehicle out of storage. Failure to so notify will result in a \$150.00 fee charge for early de-storage. Upon notification, storage officials agree to have my vehicle ready for me to pick up within (7) days or less. Taking my car out of storage for any reason will result in a \$30.00 fee for re-storage of it.

Not responsible for dead batteries that do not take recharge.

\$20 extra for oversized vehicles.

One Month's storage charges are payable when my vehicle is put into storage and the balance is payable monthly thereafter. The storage rate may not be increased during the period of this contract except upon notification to me in writing. Increases shall not exceed \$15.00 per month. I understand that the All Services Auto Storage officials are not responsible beyond the limits of insurance carried by the All Services Auto Storage. I understand that the All Services Auto Storage's insurance policies do not include loss by Acts of God.

Upon removal of vehicle from storage, it will be washed. A \$20.00 charge will be added to your statement for this service. I agree to pay for any gas or fluids that is added to my vehicle.

All Services Auto Storage is not responsible or liable for internal defects of my vehicle or for unforeseen malfunctions which may occur in starting or driving it, such as transmission, solenoid, starting motor, battery, alarms, electrical, hoses, belts, timing gears, flat tires or similar "under the hood - out of sight malfunctions" or deteriorations. I understand that if something does malfunction or break which prohibits All Services Auto Storage from being able to drive or move my car from one location to another, that they may have vehicle towed or repaired at a reasonable price and bill me for it.

I understand that All Services Auto Storage strongly recommends no personal effects to be left in car and that they are not insured. INITIALS _____

Cars that leak excessive amounts of fluids will be charged an environmental clean up fee of \$50.00.

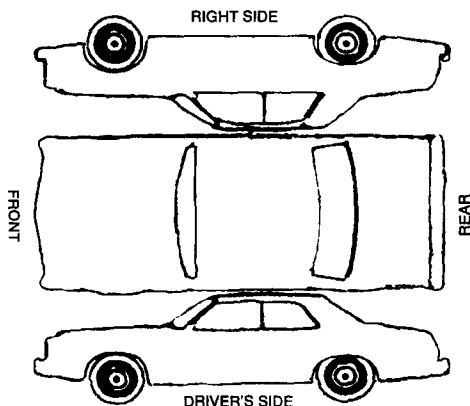
Vehicle needs to be clean enough to determine scratches or dents or A.S.A.S. will take the vehicle as is.
